

C.E. ELECTRONICS, INC. Elevator Fixtures and Accessories Elevator Digital Position Indicator

- 1.0 C.E. Electronics, Inc. warrants all its digital position indicators and accessories to be free of defects in material and workmanship for a period of one year from date of shipment to the original buyer of the product.
- 2.0 Should a defect appear during the warranty period, C.E. Electronics, Inc., at its option, will repair or replace the equipment at its factory. Such repair or replacement shall be the purchaser's exclusive remedy.
- 3.0 Any equipment deemed defective must be returned, freight prepaid, to the factory for evaluation. Any changes in circuitry or components by other than authorized C.E. Electronics, Inc. personnel will void this warranty.
- 3.1 This warranty is limited, at the option of C.E. Electronics, Inc., to the repair and/or replacement of equipment which, upon examination at the factory, is judged to be defective and subject to repair or replacement under warranty.
- 3.2 If, when returned, the product is not defective, it will be returned at the customer's expense, including a nominal handling charge, or it will be re-stocked, if possible, pursuant to current re-stocking policies and less normal re-stocking fees.
- 3.3 If new replacement units are shipped at the customer's request before the alleged defective unit is returned for inspection and evaluation, the replacement unit will be invoiced at the net price in effect at the time. The entire net price will be credited if, upon receipt and inspection of unit, a defect is confirmed. All returns of goods for confirmation of defects must be accomplished within 60 days of the date replacement units are shipped, or credit privileges will expire.
- 3.4 If in the event the returned parts were not purchased directly from C.E. Electronics, Inc., C.E. will issue a credit balance to the account of the company returning such parts to be used against future purchases. If the company returning such parts would request a cash refund they must do so through the company that purchased such parts.
- 3.5 In no event will C.E. Electronics, Inc. be liable for backcharges of any kind, including without limitation or exception, labor charges for field repair, field replacement, or late penalties.
- 4.0 This warranty does not cover damages caused by abuse, fire or acts of God.
- 4.1 In no event will C.E. Electronics, Inc. be liable for incidental or consequential damages.
- 4.2 This warranty does not cover damages caused by improper installation or maintenance.
- 4.3 The foregoing is in lieu of all other warranties, expressed or implied, of merchantability, fitness for a particular purpose, or any other thing. Purchaser assumes all liability for suitability to intended use and conformance with all applicable federal, state, and local codes and requirements. Except as stated in this warranty, C.E. Electronics, Inc. shall not be liable for any defects in, or breach of any contract, relating to the quality or performance C.E. Electronics, Inc. equipment under any theory of law, including without limitation, contract, negligence, strict liability or misrepresentation.
- 4.4 C.E. Electronics, Inc. warranty coverage does not apply to any equipment of another manufacturer used in conjunction with C.E. Electronics, Inc. equipment.
- 4.5 No returned material will be accepted for warranty adjustment without a Returned Material Authorization number issues by the factory.
- 5.0 The purchaser is responsible for all postage, insurance, or other shipping costs associated with the return of any C.E. Electronics, Inc. product for warranty evaluation or service. C.E. Electronics, Inc. will not be responsible for any damage resulting from improper packing or handling of any returned material.
- 5.1 Defective goods returned to the factory must be shipped prepaid. Collect frieght shipments will be refused. Equipment repaired under warranty will be returned to the customer via UPS, prepaid. The customer must pay expedited or overnight shipping requested by the customer. Failure to comply with any of the stipulations herein will void the warranty. Any deviation from this warranty must be agreed to by C.E. Electronics. Inc. prior to shipment of any product.

This warranty replaces and supersedes any and all previous warranties offered by C.E. Electronics, Inc.
